CANCELLATION POLICY

A deposit of \$300 is required to hold your reservation. The balance is due and must be received by Salsa Retreat before the 90th day prior to the first day of your retreat. In the event that we do not receive the full balance on the due date, we will cancel the reservation and refund any payment made less a \$300 cancellation fee.

You must cancel before the 90th day prior to the first day of the retreat in order to receive a full refund of the payment you have made less a \$300 cancellation fee. If you cancel within 90 days of the first day of the retreat no refund will be made. There will be no refunds for arriving late or leaving early. There are no exceptions to the above cancellation policies including personal injuries or weather.

We require the purchase of a third party travel insurance in order to receive a refund in case you have to cancel your vacation.

CANCELLED RETREATS

If a retreat is cancelled by Salsa Retreat, all deposits and payments made to date will be refunded in full. Guests will be allowed to reschedule for a future retreat within one calendar year of the cancellation announcement date by Salsa Retreat. Salsa Retreat will not be held responsible for any additional travel expenses incurred in connection with cancelled retreats including airline tickets.

AIRLINE FLIGHTS

You will be booking a flight into the “Benito Juarez” Oaxaca International Airport (OAX).
